

## SGT's Environmental Policy (2022-2024)

Since 1981, SGT has been able to grow in a competitive market and in a sector weakened by plastic bashing. Our goal is to be considered as a reference among preform manufacturers so that our employees are proud to be involved and our customers are proud to have us as a supplier.

We are aware of the environmental impact of our industry and therefore we respect the environmental laws as an ICPE company. We want to go further by continuously improving our environmental impact for several years.

### 1. To prevent and limit waste production

Through our sorting efforts and the involvement of every employee in the company we have reduced our Non-hazardous industrial waste by 49% in tonnage from 2019 to 2022, surpassing our three-year targets.

- ✓ We will continue our sorting and collection efforts to reduce the tonnage of NHIW by 30% by 2024;
- ✓ We process and recycle our production waste and plan to regenerate some of it in our subsidiary SGR;
- ✓ We promote exchanges and best practices with our stakeholders;
- ✓ We will roll out sorting and collection by equipping all our facilities with the appropriate equipment by 2022;
- ✓ We are aiming for zero emissions of microplastics into the environment and compliance with french decree no. 2021-461 for our 2 plants

### 2. To reduce energy consumption

For several years we have been investing in the latest generation of equipment and have been able to maintain our energy consumption per ton of PET processed.

- ✓ We will continue our efforts to reduce consumption by 1% per year;
- ✓ We will make our teams aware of the simple gestures of daily life.

### 3. To be an actor in the circular economy

#### Through an economy of functionality

- ✓ By orienting our purchases towards rental and service whenever possible.

### Through industrial and territorial ecology

- ✓ We wish to reference at least 50% of our suppliers on the French territory.

### Through effective management of end-of-life materials and products

- ✓ We are developing partnerships with retailers to deploy bottle collection points throughout France;
- ✓ We collect our pallets to have them repaired if necessary so that they can be reused;
- ✓ We want to maintain a minimum recovery rate of 97% for our waste.

### Through responsible consumption

- ✓ We offer reusable packaging in cardboard or metal wire boxes and collapsible plastic boxes.
- ✓ We have been working for several years with our customers to incorporate recycled material in our preforms in order to reach the objectives of the European regulation (SUP: Single Use Plastic) and thus to have less impact on fossil resources; We have the MORE (Mobilized to Recycle) label since 2019;
- ✓ We develop eco-designed products with our customers;

## 4. To limit the impact of our activities on the climate

- ✓ We have built a PET regeneration plant, the SGR, to control the quality of our recycled raw materials and optimize supply distances through local sourcing and deliveries to our customers. We plan to install a second one on the Rezé site in early 2024;
- ✓ We have built a new production site in the Eastern region in order to reduce delivery distances for a number of our customers;
- ✓ In 2022, we are initiating a calculation of our greenhouse gas emissions (SCOPE 3) in order to measure their impact and to set actions that would allow us to reduce them by 15% by 2030, mainly on the material part.

As CEO of SGT and SGR, I am entrusting Michel Roué, Director of Operations, and the Site Directors with the mission of implementing this policy.

I ask all employees to get involved in the process to ensure its success.

I am personally committed to providing all the support and resources necessary to improve our environmental impact and achieve the goals we set for ourselves.
